In such event, any unused tuition will be refunded minus any outstanding charges for late fees, costs, etc.

The Parent/Guardian must provide two weeks written notification prior to the child's last day at the Center to end this Enrollment Agreement. If notification is less than two weeks the Parent/Guardian agrees to pay \$55.00 per day for any unpaid days within the two week period.

In the event the Parents/Guardians engage staff of the Center for outside child care services, the Parent agrees that such engagements are not related to the Center or its owner. Parents release and discharge the Center and its owner from all claims, demands, liabilities, actions or causes of action whatsoever, whether known or unknown, which Parents/Guardians have, may have or claim to have anytime in the future based in whole or in part on or arising out of or related to any outside engagement. Parents/Guardians must provide a signed statement for a staff member to be an authorized person to whom the child may be released.

If the Parents/Guardians fail and/or otherwise refuse to abide by any of the terms and conditions set forth herein including, but not limited to, payment of any and all frees, tuition charges or other amounts as described and agreed to, the Center shall be entitled to make claims for any and all sums due and owing, with interest at a rate of one and one-half (1½%) per month, plus payment of costs incurred, and all responsible attorney's fees necessitated by the making of any such claims, including, but not limited to, the filing of any legal action for collection of said amounts.
